Dear Residents, Family Members & Friends,

Today we are delighted to share some wonderful news. **Public Health has shared with us just today, that we are going to be vaccinating all our Shalom residents in the next week to 10 days due to the early shipment of Moderna vaccine to Hamilton.**

In preparation of this process, we will be making calls to all Shalom residents, or the Power of Attorney on their file, as early as this weekend, to arrange for consent. All residents will receive the vaccine, unless they are acutely ill at the time of vaccination, whereby vaccination will occur when they are stable.

Attached is the consent form for your review as we will be getting verbal consent only and documenting the information. Please let the staff know if you have any outstanding concerns about your family member and we will look to getting you a call back as soon as possible in collaboration with the Physician if necessary.

Currently, Shalom Village has 17 active cases of COVID-19. Below you will find today's COVID-19 update:

- Number of staff who have tested positive for COVID: 81 (66 resolved)
- Number of resident positive COVID Cases: 104 (12 Active & 68 Resolved)
 - Apartments/Assisted Living: 16 (8 resolved – 5 active)
 - 1 in SVO 1st floor
 - 5 in SVO 2nd floor
 - 3 in SVO 3rd floor
 - 6 in SVO 4th floor
 - 0 in SVToo 3rd floor
 - 0 in SVtoo 4th floor
 - Long Term Care (LTC): 88 Positive tests (60 resolved – 12 active)
 - 23 in SVO 1st floor (18 resolved)
 - 30 in SVO 2nd floor (23 resolved – no active cases)
 - 22 in SVToo 1st floor (15 resolved)
 - 13 in SVtoo 2nd floor (4 resolved)

** In addition to this, 4 essential caregivers have also tested positive (3 resolved), and 1 individual is in hospital. We are sad to say that, to-date, we have had 19 individuals pass-away from COVID-19. We are devastated by their loss, and offer our sympathy and condolences to their family members and loved one's.

* Symptoms of COVID-19 can include fever, new onset of cough or worsening of chronic cough, shortness of breath, difficulty breathing, sore throat, difficulty swallowing, decrease or loss of smell or taste, chills, headaches, unexplained tiredness / malaise / muscle aches, nausea / vomiting, diarrhea or abdominal pain, pink eye, or runny nose or nasal congestion without other known cause or, for those over 70 years of age, an unexplained or increased number of falls, acute functional decline, worsening of chronic conditions or delirium

** Polyethylene glycol (PEG) can rarely cause allergic reactions and is found in products such as medications, bowel preparation products for colonoscopy, laxatives, cough syrups, cosmetics, skin creams, medical products used on the skin and during operations, toothpaste, contact lenses and contact lens solution. PEG also can be found in foods or drinks, but is not known to cause allergic reactions from foods or drinks
